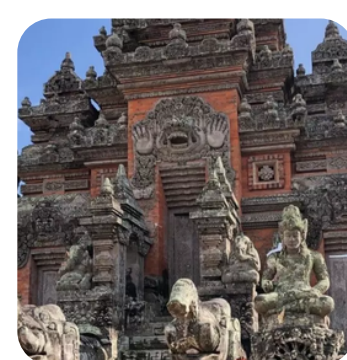

- Batubulan Village Tourism area with cultural performances of Barongan Dance, Kecak Dance and Legong Dance

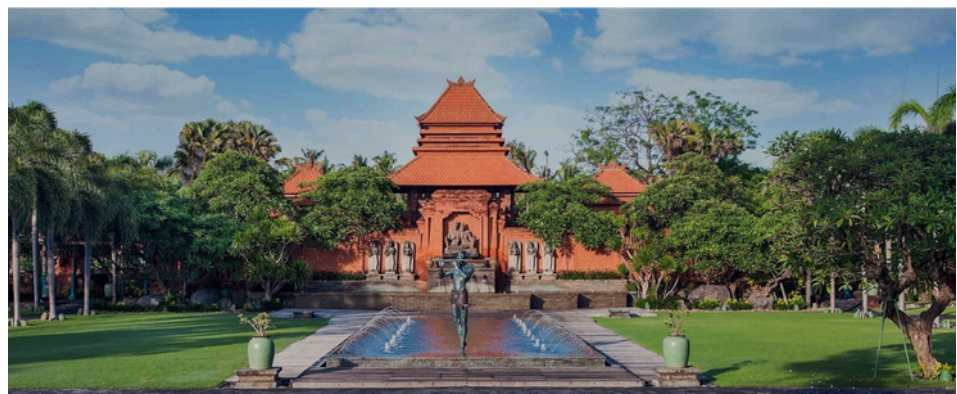

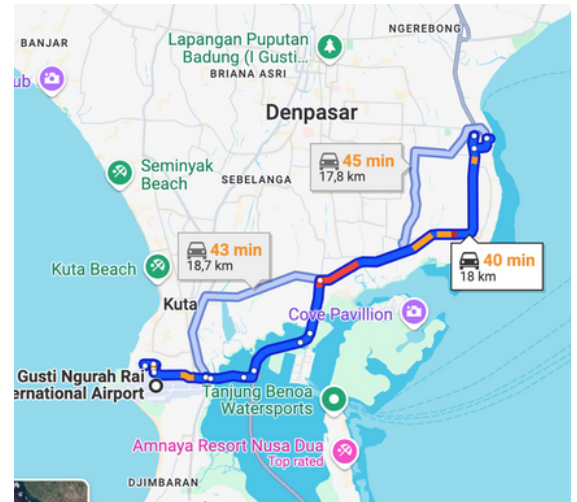
